Politics and the Pandemic

Whew, it's not only been hot outside, but the intensity of political discourse is heating up considerably as we approach the election. Unfortunately, that also means the rhetoric on the pandemic is getting more confusing and politicized. Statements about what works and what doesn't, what's serious and what isn't, and who is doing the right thing and who isn't have become increasingly divisive and political. Case Rates and Tier Status in Marin

Earlier in the week, Dr. Willis reviewed the requirements for case rates, test positivity rates, and quartile test positivity rates for each tier status.

Currently, two of Marin's three measurements qualify for Tier 3 (orange status). For Marin to officially achieve Tier 3 (orange status), two things need to happen: (1) the adjusted case rate must equal or fall below 3.9, and (2) Marin's data must remain within the Tier 3 range for two weeks. If Marin's data continues to improve, we could achieve Tier 3 status as early as October 27. Dr. Willis pointed out that the change in status is only possible if we continue to work as a community to slow the spread of COVID–19. In other words, wear a mask, stay 6 feet apart from others, avoid crowds, focus on outdoor activities rather than indoor and wash your hands frequently!

VOTING IN THE TIME OF COVID

Far and away, the best way to vote during the pandemic is by mail.

The Marin County Public Health and Marin County Elections
Departments issued a joint press release confirming this advice on
Friday. As pointed out in the press release, "voting by mail limits
contact with others outside of a voter's household, and that's the key to
reducing the spread of COVID-19 and flattening the curve." Ballots
must be postmarked by November 3. Best if you mail them early!

The County has also arranged for multiple secure drop boxes where ballots can be deposited instead of at polling places. Two are drive-through drop boxes which allow you to drop off your ballot without having to exit your car. Both of these are at the Civic Center in San Rafael in the archways:

Vera Schultz Drive (North Archway) Peter Behr Drive (South Archway)

You can <u>check the location of other drop boxes</u> on the County website. Don't assume a drop box is official until you have double-checked!

There will also be drop boxes at polling places which will be open October 31 – November 3. The list of polling stations and hours of operation can be found here.

Those who choose to vote in-person must vote at the polling place to which they were assigned (check your voter information/sample ballot guide if you are uncertain). You will be required to practice social distancing and must wear face coverings. If voters don't have personal protective equipment available, the County will provide it. All Elections staff and volunteers will be required to wear face coverings. Hand sanitizer will be available at the entry and exit of all in-person polling places and staff will sanitize equipment regularly.
